- Elite Dance Academy sends most information via email. It is your responsibility to ensure that Elite Dance Academy has your current email address and that you have enabled your account to receive emails
- Students are required to wear the appropriate dance wear to class (please see the dance attire sheet provided by Elite Dance Academy)
- Students are required to have their hair done for class (please see the dance attire sheet provided by Elite Dance Academy)
- Names should be in ALL dance attire, ESPECIALLY shoes
- Parents are required to notify the office if a student will be absent
- Students are responsible for any damages they may cause to Elite Dance Academy's property
- Elite Dance Academy has the right to refuse service
- Elite Dance Academy and its staff are not responsible for damages or loss of

Tuition & Cancellation Policies

Summer Drop In Classes

- Tuition is due at the time of registration.
- Elite Dance Academy reserves the right to cancel classes due to low registration. A full refund or studio credit will be provided.
- If you need to withdraw from a class please email admin@elitedanceacademy.ca with this request at least 24 hours in advance. A full class credit will be applied to your account.
- Student Cancellation Policy - No refunds or credits for classes that are cancelled within 24 hours.
- Elite Dance Academy reserves the right to cancel classes (without refund) due to unforeseen circumstances (eg - weather, act of God, Covid 19).

Sessional Classes

- Tuition is due at the time of registration.
- Elite Dance Academy reserves the right to cancel classes due to low registration. A full refund or studio credit will be provided.
- If you need to withdraw from a class please email admin@elitedanceacademy.ca with this request at least 24 hours in advance. A full class credit will be applied to your account.
- Student Cancellation Policy - No refunds or credits for classes that are cancelled within 24 hours.
- Elite Dance Academy reserves the right to cancel classes (without refund) due to unforeseen circumstances (eg - weather, act of God, Covid 19).

Full Season Classes (September - June)

Tuition & Fees:

- **A registration fee will be due and processed at the time of registration and this is non-refundable.**
- **September Tuition will be due and processed at the time of registration and this is non-refundable.**
- **June Tuition will be due and processed on September 1st, 2025 and this is non-refundable**
- **Tuition for October - May will be processed on the 25th day of the previous month.** (eg - October tuition will be due and processed on September 25th, 2025).
- Each student must be set up on an automatic monthly payment plan. ONLY monthly tuition payments will be charged to the credit card or EFT account on file unless otherwise instructed from you
- The dance term fees are based on a minimum of 34 weeks of classes, split over 10 equal payments (monthly payments are not prorated)
- The office must be notified of monthly payment changes (i.e. changes to your credit card or checking account) prior to the 25th of the month before the payment is due
- If your credit card is compromised please notify the office

Withdrawal Policy:

- Tuition for the month of September, the month of June and the registration fees are non-refundable but can be transferred to a different class selection in the same month (unless approved by Elite Dance Academy).
- Notice must be given for the cancellation of any class, via letter or email, to the office before the 20th of the month prior the month of withdrawal
- **If a student withdraws after the 20th of the month, the following month's tuition will still be charged and no refunds will be given**

Classes and Studio Closures:

- The dance term consists of a minimum of 34 weeks
- No refunds will be given for missed classes

- Elite Dance Academy reserves the right to cancel classes (without refund) due to unforeseen circumstances (eg - weather, act of God, Covid 19).
- The studio closes for Stat Holidays and long weekends. Classes on these days will be cancelled. The studio closes for a fall break, winter break and for spring break (exact dates will be emailed) and these weeks are not included in the 34 week term
